Ethics and E&O sometimes go together. Not 100% of the time, but in part there are many ethical considerations to consider. Arizona courts have established a high standard of care for Arizona agents in a Duty to Advise. This seminar will explore Ethical Consideration, duties, responsibilities and obligations in areas such as: Duty to Advise, Record Retention, CGL E&O Issues, CGL Endorsements gone wild, and Claims-Made Policies and what you need to know to avoid a claim.
